Oak Ridge Improvement Association Annual Meeting Minutes May 18, 2022

Kevin Knox, President, opened the meeting at approximately 6:30 pm at the pool.

Members Present:

Kevin Knox-President Wendy Wells-Vice President Secretary- Open Treasurer-Open

Opening Statement:

Kevin discussed a brief history of the pool memberships and Associate memberships. Kevin stated how Marc Lund and Chuck Barton were key players in getting the pool open over the years. He also announced that the current board members would be terming out and new board members would be elected later in the meeting.

Statement of Operations from 2021:

Kevin discussed the Statement of Operations from 2021 (attached) and reviewed each type of revenue and the line items expenses showing a net of \$5,565. There is \$7,246 going into 2022 with approximately \$1,700 in savings. He stated that he was changing CPA firms due to dissatisfaction with their performance.

Pool/Grounds Update:

Chuck Barton discussed the pool and explained that we wouldn't know of any real problems until the pool was actually filled and valves were turned on. He briefly outlined some areas that would need future attention/repair/maintenance. He recognized Eric Anderson, Brian Johnston, Nathan Randall, the Kebels and others who have volunteered their time to get the pool operating. Chuck discussed the Volunteer List (attached) looking for help to get the pool and its grounds prepared for the season. There was discussion about the weather forecast (measurable snow) and potential delays in getting the pool open by Memorial Day weekend.

Voting for Associate Membership:

Wendy Wells discussed that outside homeowners have requested if there would be Associate Membership for the 2022 season.

A motion was made that there would be no outside Associate Membership for 2022. Kevin Know ask for a vote from members present and the members on Zoom. The vote was unanimously to deny any Associate Memberships for the 2022 pool season.

Key Distribution/Security for 2022:

Wendy Wells announced that there would be new pool keys distributed for the 2022 pool season. The new Keys would be distributed after each homeowner sign a pool wavier. There was a discussion about security around the pool and that there were no incidents in the 2021 pool season. The previous Vice President, Doug Lundin, had prepared a proposal to replace and expand the current camera system. Since there were no incidents, the Board will monitor the need to replace the cameras for the upcoming seasons.

Social Committee:

Wendy Wells discussed that at the end of the pool season last year, there had been requests for some HOA members to host get-togethers/social activities. Wendy Wells stated that on the table, a sign-up sheet was available for volunteers to create a Pool Committee to hosts social activities. (attached)

Sports Court Update:

A proposal to repair and expand the capabilities of the Sports Court was developed by Ed Kolb (attached). A couple of HOA members had volunteered to review and repair the net poles allowing tennis, pickleball, volleyball and badminton to be played on the court. Ed's proposal of adding a pickleball court (or two) using tape or paint on the court surface was discussed and a member expressed concern that an actual pickleball does not bounce as it should on the current surface. The members have tabled this proposal for further investigation.

Board Nominations:

Kevin nominated Sarah Moseley as Treasurer It was seconded by Michaela Bacon

Wendy Wells nominated Marilyn Henderson for the Secretary position It was seconded by Kitty Armstrong

Kevin Knox nominated Eric Anderson Wendy Wells nominated Lisa Murray as Board Members It was seconded by Jenny Orr

Kevin Knox nominated Wendy Wells to continue as Vice President.

The slate of nominated officers was voted on and accepted by the members.

Kevin Knox discussed the Architectural Review Committee and the need for new members. He nominated Carla Reade; Michaela Bacon and Iris Gavin volunteered to join the committee.

Open Discussion:

Susan Noll made comments regarding the changing of officers on the Board and thanking, Kevin Knox, Marc Lund, and Chuck Barton for their many years of service to the HOA and its Board.
